






What's Power Automate?

- Power Automate is a comprehensive, end-to-end cloud automation platform powered by low code & AI. With it you can
 - Automate processes based on triggers
 - Create flows that will run on click of a button
 - Connect to multiple systems to integrate data
 - Combine with AI tools to help develop & work with your data
 - Create triggers from Business Central, Dataverse, or multiple other applications!

Power Automate Flow Trigger

- "When a purchase document approval is requested (V3)"
- Select your Environment & Company
- Provides ability to filter on four Header conditions & four Line conditions
- Can filter by type to only process
 Purchase Orders or Purchase Invoices
- Can create multiple flows with different criteria
- Filters are not required

Power Automate Approvals


- Approvals are included for everyone with Power Automate
- Start, Wait, & "Start and Wait"
- "Approval type" allows for waiting for all approvals or proceeding on the first approval
- Can customize approve/reject options





Things to Know

- Approvals have a 28-day limit for the wait & Flows have a 30-day limit before they time out
- If the flow fails, the order gets left in the "Pending Approval" state
- Can be difficult to know who has & has not approved yet
- Lack of visibility to Approvals created by other people
- Approvals are done outside of Business Central in Power Automate
- Currently, no way to mass approve requests



Pros & Cons

- Out-of-the-Box
 - Better visibility
 - Limited configurability
 - All work done in the same system
 - Business Central licensing required for all users involved in the process

- Power Automate
 - Lacking some visibility
 - More configurable
 - Multiple systems used
 - Business Central licensing not required for people who just need to approve/reject
