




### **Number of Regional Whole Bank & Thrift Transactions**


# Regional Average Tangible Book Premium to Core Deposits [1]

# National Average Deal Value to LTM Earnings







**National Average Deal Value to Tangible Book** 




**National Average Deal Value to** LTM Earnings



National Average Deal Value to LTM Earnings by Performance\*




